Number of Games: Each team is guaranteed a minimum of 4 games. The possibility exists for some teams to play 5 games. Tournament is pool play, round robin, or single elimination to the championship rounds depending on number of teams per division.

Entries: Limited to 50 teams overall; individual divisions will be limited based on facility space and/or registrations received

- Rosters: The roster established at the time of the first game must be used throughout the entire tournament. Additions or changes are not permitted.
- Players: Players, or teams, may play up a grade but not down a grade (exceptions may be made for very small schools). Boys and girls can only play in their division (e.g. girls will only play in the girls division) and a player may only be assigned to one team per grade during the tournament.
- Rules: NFHS rules will apply with few exceptions. 7 minute quarters for grades 4 - 8. 6 minute quarters for 3rd Grade. All technical/intentional fouls: 2 points awarded and possession. Women's size basketballs will be used with the exception of the 7th & 8th Boys' Divisions. Youth size ball will be used for 3rd Grade divisions. Each team must present a "best ball" prior to each game. Game time is forfeit time
- Warm-up: Minimum 5 minutes will be provided prior to game time.
- Scorekeeper: Each team must provide one person to keep individual and team statistics on score sheets provided. Scorekeepers will be provided free admission.
- Coaches: Only one coach per team will be provided free admission. More than 1 person may coach.

AAU Member Club Compliance Form CONCUSSION LAW REQUIREMENTS

Required by AAU Event Operators to participate in AAU sanction events

HB1824, otherwise known as the Zachery Lystedt Law, was signed into law on May 14, 2009. It requires, as of July 26, 2009, that additional steps be taken regarding concussions in private nonprofit youth athletic programs using school district facilities.

This bill requires training and documentation which AAU Member Clubs must adhere to. AAU players and their parents/guardians must meet these minimum requirements and submit the required documents along with the tournament entry form:

1. All AAU member coaches will have to take training on the nature and risk of concussions and head injury including continuing to play after a concussion or head injury. Coaches must sign and return the Concussion Fact Sheet prior to initiating team practice or competition.
2. On a yearly basis, a concussion and head injury fact sheet shall be signed and returned by the youth athlete and athlete's parents/guardian prior to the youth athlete's initiating practice or competition.
3. All athletes suspected of suffering a concussion or brain injury will be removed from practice or competition and not returned to play until cleared in writing by a licensed health care provider trained in the evaluation and management of concussions (Medical Doctors, Doctor of Osteopathy, Advanced Registered Nurse Practitioner, Physicians Assistants, and *Certified* Athletic Trainers).
